

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON SEPTEMBER 16, 2008.

Meeting called to order at 9:00 a.m. by Chairman Larry Backer with members Ken Oldenburger and John Zimmerman present.

Minutes of the previous meeting were read and approved as read.

Board proceeded to open sealed bids for rental of the County Farm (approximately 281 acres). Present were John Wessels, Justin Abell, Dan Engels, Vern Leerhoff, Nolan Junker, and Greg Asche.

The following bids were received:

Those bidders present were then allowed to raise their respective bids in increments of not less than \$200. At the close of said bidding, it was moved by Oldenburger, second by Zimmerman to accept the high bid of \$92,200 for the 2009-2010 crop year. Motion carried.

Board met with Emergency Management and Veteran Affairs Director Steve Ulrichs to discuss his request to increase a part-time Office Assistant position to full-time. After much discussion it was determined that the Board did not favor making the position full-time, however did acknowledge the hourly wage for said position of \$10.49 was insufficient for the work performed. It was moved by Zimmerman, second by Oldenburger to increase the hourly rate for said position to \$12.99 effective September 22, 2008. Motion carried.
