

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS  
HELD ON APRIL 21, 2009.

Meeting called to order at 9:00 a.m. by Chairman Ken Oldenburger with members John Zimmerman and Karl Nelson present.

Minutes of the previous meetings were read and approved as read.

Board met with Pat Derdzinski, Butler County Agricultural Extension Director, to hear program update.

Board reviewed correspondence dated April 14, 2009 from Marlene Smith in which she appealed the amount of property taxes she was assessed. The Board of Supervisors declined to take any action on said request.
