

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON JULY 28, 2009.

Meeting called to order at 9:00 a.m. by Chairman Ken Oldenburger with members John Zimmerman and Karl Nelson present.

Minutes of the previous meeting were read and approved as read.

Board considered Iowa Department of Public Health County Substance Abuse Prevention Request for Bid for Fiscal Year 2010. Moved by Zimmerman, second by Nelson to approve same. Motion carried.

Jim Norton was present.

Board met with Alisa Brown to hear inquiry as to why Butler County does not have a Housing Code. Also present were Zoning Administrator Steve Busse, Environmental Health Specialist Mike Weinberg, Public Health Director Jennifer Becker, and County Attorney Greg Lievens. Ms. Brown questioned why rural areas of Butler County did not have a housing or building code. She reported the she and her roommate have observed that contractors may be performing substandard work and there is no oversight to eliminate it. Busse reported that all farmsteads are exempt from such codes by law and that there has not been support for such regulations in the past for the rural area. He also stated that all work performed in Iowa has to meet the State building codes. Lievens stated that adoption of such codes and enforcement would be a financial burden on the county, but felt that much of the costs could be recovered by fees for services. He also stated that an arrangement could be made in which the county contracted with a private entity to provide the service and not actually take on additional county employees. He indicated that he felt the matter was worth pursuing. Nelson stated he thought the State would ultimately mandate a uniform building code for rural areas and felt that it was acceptable to wait until such time to take any action on the matter. Ms. Brown stated she felt such a code was critical to protect homeowners. Oldenburger stated that the matter would be investigated sometime in the future, possibly through Public Hearings to obtain feedback from citizens.

Moved by Nelson, second by Zimmerman to authorize the Auditor to transfer \$15,000.00 from General Basic to Self Funding for Fiscal Year 2010. Motion carried.

Board considered Secretary of State's Grant Agreements for minor repairs of polling places in Parkersburg, Greene and New Hartford. Moved by Zimmerman, second by Nelson to approve same. Motion carried.

Board met with Treasurer Louise Squires. Reviewed Treasurer's Semi-Annual Report and ordered placed on file.

Board met with Butler County Development Director Jeff Kolb to hear brief program update.

Board acknowledged receipt of Manure Management Plan Annual Update for IL/IA L.L.C.

Moved by Zimmerman, second by Nelson to authorize the County Auditor to issue checks for the claims on file for the month of July 2009 as follows:
