

**MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON FEBRUARY 28, 2017.**

Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Rusty Eddy and Greg Barnett present. Also present were Engineer John Riherd, Sheriff Jason Johnson, Zoning Administrator Mitch Nordmeyer, Connie Rottink, Butler County Wellness Committee and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

**RESOLUTION #876  
CONSTRUCTION ROAD CLOSURE**

WHEREAS, The Butler County Board of Supervisors is empowered under authority of the Code of Iowa to close roads or highways under their jurisdiction when necessary for construction, and

WHEREAS, a bridge replacement project, L-Culv17--73-12 (site H24W), requires that Butler County Route T63 from 200<sup>th</sup> Street north 1 mile to C33 (190<sup>th</sup> Street) be closed to thru traffic, and

WHEREAS, local traffic in the vicinity of the construction project will be maintained outside of the construction limits of project L-Culv17--73-12 (site H24W), and

WHEREAS, thru traffic is encouraged to follow signed detour route, and

NOW THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that the above described roads and bridge is to be closed and proper signs erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.

Moved by Heidenwirth, second by Barnett to accept the recommendation of Engineer Riherd and approve a Utility permit for Butler County REC for a new overhead line to serve 11520 105<sup>th</sup> Street. All Ayes. Motion carried.

Board continued discussion regarding sale or lease of the County Farm land for a REC photovoltaic solar project and shared storage for Emergency Management and Butler County Conservation. Also present were Conservation Director Mike Miner and Paul Leerhoff, Clarksville, Iowa. Zoning Administrator Mitch Nordmeyer advised that based on the Zoning Ordinance and a Corn Suitability Rating of 91, it was not in the best interest of the County to take the acres out of production. Paul Leerhoff, Board of Adjustment, agreed with Zoning Administrator Nordmeyer. Conservation Director Mike Miner commented that they did not consider factors that have come to light and will continue to look for a suitable location. No action taken. A decision on the matter will be on the agenda for the March 7, 2017 meeting.

Board acknowledged receipt of Manure Management Plan Annual Updates for Roose South Finisher Farm; Quail Finisher Farm; Winkowitsch Finisher Farm; Summit Farms Finisher Farm; Kuper Finisher Farm; Brad Finisher Farm; McCandless #2 Finisher Farm and Marton/Butler Finisher Farm.

Also present was Habbo Fokkena, Clarksville, Iowa. Fokkena opined that the Board should allow the County Farm land to be used and that it could be leased at a profit. Fokkena suggested that with the aging population of the County, the Board needs to look at the long range picture, as financial gain with farm land will not be revenue of the future. He further suggested that the Board consider a review of the Comprehensive Plan to evaluate if this is an effective tool to grow the population.

Moved by Barnett, second by Eddy to adjourn the meeting at 10:33 A.M. to Tuesday, March 7, 2017 at 9:00 A.M. Motion carried.
