

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON AUGUST 1, 2017.

Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Rusty Eddy and Greg Barnett present. Also present were Engineer John Riherd, Greg Forbes, Parkersburg Eclipse, John Anderson and Kenny Coates, New Hartford, Iowa and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

Board met with Mayor John Anderson and Kenny Coates from New Hartford to discuss a culvert on T55. Water is being directed north along T55 towards New Hartford. City of New Hartford is requesting a flap be installed on a trial basis along the southeast side of the culvert which they could close during periods of high water. Engineer Riherd suggested that the city submit a formal letter of request and a drawing of proposed structure to the Engineer and the Board of Supervisors for approval.
