Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Rusty Eddy and Greg Barnett present. Also present was Bethany Carson, Mid-America Publishing.

RESOLUTION #893

RESOLUTION DIRECTING TRANSFER OF METLIFE ANNUITY CONTRACT ENDING IN 9828 TO/FOR RIGHTFUL OWNER DEBORAH JEAN McWHIRTER ACCORDING TO HER INSTRUCTIONS

WHEREAS, an annuity contract was created with MetLife for a 457 DCP annuity which incorrectly listed the owner of the annuity contract as Butler County 457 DCP instead of former employee Deborah Jean McWhirter; and

WHEREAS, the annuity company requires a corporate resolution from the stated owner, Butler County 457 DCP, showing the signatures of all authorized signers in order to proceed with the transfer of the funds as desired by McWhirter; and

WHEREAS, Butler County acknowledges the proceeds are entirely and rightfully owned by McWhirter and should be transferred to McWhirter's ownership as directed by her;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BUTLER COUNTY, STATE OF IOWA:

Chairman Tom E. Heidenwirth, or his pro-tem is authorized by Butler County to execute all documents necessary to facilitate the transfer of the funds of Met Life annuity contract ending in 9828 funds which lists the contract owner as Butler County 457 DCP to McWhirter or as directed by her.
