Meeting called to order at 9:00 A.M. by Chairman Greg Barnett with members Rusty Eddy and Wayne Dralle present. Moved by Dralle second by Eddy to approve the agenda. All ayes. Motion carried.

Minutes of the previous meeting were read. Motioned by Dralle, second by Eddy to approve the minutes as read. All ayes. Motion carried.

No public comment was received.

Kari Coates, EMS Coordinator, provided an update. She and Tammy completed their EMS instructor training and are looking to start classes early next year. Coates has met with cities and is on the register for all county services. She has gone on a total of 23 calls within the five weeks she has been live. Coates also stated that there are 23 new AED's coming in that are free through a grant program. It was discussed to have County employees trained in basic CPR and AED.

Board considered Resolution 1090-2023 Compensation of Township Trustees and Clerks. Leslie Groen, Auditor, discussed the pay for Township Clerks and Township Trustees and establishing an hourly rate of pay of \$13.50 for any action taking place outside the normal meetings. Moved by Eddy, second by Dralle to approve Resolution 1090-2023. Roll was called and Resolution 1090-2023 was adopted as follows:

RESOLUTION <u>1090-2023</u> Compensation of Township Trustees and Clerks

WHEREAS, the Butler County Board of Supervisors previously authorized that all Township Trustees be compensated at the rate of \$30.00 per meeting, and

WHEREAS, all Township Clerks were previously authorized to be compensated at a scheduled rate of \$150 in June and \$150 in December, for a total of \$300 per year for their duties, and

WHEREAS, pursuant to Iowa Code 359.46, the Board of Supervisors will establish an hourly rate of \$13.50 when engaged in official business outside of the previously established Township Trustee rate of \$30 per meeting and Township Clerk rates of \$300 per year.

THEREFORE; a motion was made by <u>Eddy</u> and seconded by <u>Dralle</u> authorizing the County Auditor to compensate Township Trustees and Clerks at an hourly rate of \$13.50 for official business outside of the previously stated compensation; with exceptions noted in Iowa Code 359.46 (a) and 359.46 (b).
