# AN ORDINANCE REPEALING ORDINANCE NO. 6 AND ESTABLISHING THE COUNTY SUPERVISOR DISTRICTS AND ELECTION PRECINCTS

**BE IT ENACTED** by the Board of Supervisors of Butler County, Iowa:

<u>Section 1. Purpose</u>: The purpose of this ordinance is to repeal totally Ordinance No. 6 and establish election precincts and County Supervisor districts as the result of the population changes reflected by the 2000 federal decennial census, in accordance with Iowa Code Sections 331.210A and 49.7.

<u>Section 2. Boundaries of Election Precincts</u>: Butler County shall have twelve (12) election precincts whose boundaries shall be as follows:

Albion Precinct: Albion Township, including the City of Parkersburg.

**Beaver Precinct**: Beaver Township, including the City of New Hartford, but excluding that part lying East of Willow Street and North of 302<sup>nd</sup> Street and that part lying North of 290<sup>th</sup> Street between Willow and Viking Avenues.

Bennezette Precinct: Bennezette Township, including the City of Aredale.

**Coldwater Precinct**: Coldwater Township, including the City of Greene, and that part of Dayton Township lying North of 120<sup>th</sup> Street and West of Oak Avenue.

**Dayton-Fremont Precinct**: Dayton Township except that part lying North of 120<sup>th</sup> Street and West of Oak Avenue and Fremont Township.

**Jackson-Butler Precinct**: Jackson Township, excluding the City of Allison, and Butler Township, including the City of Clarksville.

**Jefferson-Shell Rock Precinct**: Jefferson Township, Shell Rock Township, including the City of Shell Rock, and that part of Beaver Township lying East of Willow Street and North of 302<sup>nd</sup> Street and that part lying North of 290<sup>th</sup> Street between Willow and Viking Avenues.

**Madison, Ripley & Washington Precinct**: Madison Township, Ripley Township, and Washington Township, except that part lying East of Cedar Avenue and South of 310<sup>th</sup> Street.

**Monroe Precinct**: Monroe Township, including the City of Aplington but excluding the City of Parkersburg, and that part of Washington Township lying East of Cedar Avenue and South of 310<sup>th</sup> Street.



**Pittsford Precinct**: Pittsford Township, including the City of Dumont, but excluding the City of Bristow.

West Point-Allison Precinct: The East one-half of West Point Township, including the City of Allison.

West Point-Bristow Precinct: The West one-half of West Point Township, including the City of Bristow.

<u>Section 3.</u> <u>Boundaries of Supervisor Districts</u>: The boundaries of the three supervisor districts shall be as follows:

Supervisor District #1 is made up of Dayton-Fremont Precinct, Jackson-Butler Precinct, and Jefferson-Shell Rock Precinct.

Supervisor District #2 is made up of Bennezette Precinct, Coldwater Precinct, Madison, Ripley & Washington Precinct, Pittsford Precinct, West Point-Allison Precinct, and West Point-Bristow Precinct.

**Supervisor District** #3 is made up of Albion Precinct, Beaver Precinct, and Monroe Precinct.

**Section 4. Effective Date**: This ordinance shall be effective on January 15, 2002, after its final passage, approval, and publication as provided by law.






