Board acknowledged receipt of Manure Management Plan Annual Updates for Rottler Farms Finisher, Spain Finisher Farm, RB Spain Finisher Farm; Brocka Finisher Farm; RB Real Site Finisher Farm; Feckers Finisher Farm, RB Poppen Finisher Farm, and RB DeGroote Finisher Farm.

Board met with L. J. Bohluis, Doyle Voss and Carolyn DeVries to hear concerns about drainage problems in the unincorporated city of Austinville. Also present was County Engineer John Riherd. Voss reported that in 1993, with the County's assistance, a tile was put in place to drain water from Austinville into Beaver Creek. Voss indicated the tile is now exposed for a number of feet at the creek due to bank erosion. He also questions whether the metal guard is still in place at the end of the tile. He stated their request is that the County examine the tile and determine what repairs are necessary as well as stabilize the bank to avoid further erosion. He further requested the culverts in the community be inspected and cleaned if necessary. The Board indicated that County Engineer John Riherd will look into necessary repairs and stay in contact with Mr. Voss.

Board met with Shell Rock City Council members Ben DeWitt and Glen Kliebenstein as well as City Maintenance Director Mike Tellinghuisen. Also present was County Engineer John Riherd and Sheriff Jason Johnson. Riherd presented a written report detailing what has transpired between the City and County regarding the Shell Rock Bridge Project. Riherd indicated that early in the project he had indicated a willingness to provide certain inspection services at no cost to the City, however as the project moved forward it became increasingly more complex. Due to the increased complexity, Riherd indicated he was no longer willing to provide supervision and inspection services at no cost to the City. He stated he felt the City was large enough to bear the costs of the project without county assistance. Tellinghuisen requested Riherd clarify just what the City could now expect in assistance from the County. Riherd proposed he could offer an inspector on site 40 hours per week, with oversight by Calhoun-Burns & Associates, at an approximate cost to the City of \$40,000 or less. Riherd indicated he would make every attempt to keep costs down. The parties agreed to work together throughout the life of the project.

Board further reviewed proposed County Budget for Fiscal Year 2011/2012.

Moved by Heidenwirth, second by Nelson to adjourn to Tuesday, February 8, 2011, at 9:00 A.M. Motion carried.
